## **Summary:**

### **Update of Regional Grants**

The meeting opened with Update of Regional Coordinator Reports from Region 2, 3, 4, 6, and 8. The reports give status of grant process and expected funding requests for next grant cycle to complete Type II build out and build Type I teams in the region. With the amount of information reported it was requested that each Regional Coordinator give send a report via email to the Chair on status of regions and number of teams needing funding in next grant cycle.

### **Mass Decon Discussion**

Discussion on TAC responsibilities of Mass Decon and concerns. Defining of Mass Decon, Technical Decon, and Gross Decon led to review of Target Capability list and concerns of response times for Hazmat to cover Mass Decon. TAC decision to review Hazmat Tech Training Manual being created by Fire Academy and look at definitions and guidance for future training. Discussion on what responsibility Hazmat has on Mass Decon and timeframe it can be provided. Committee thoughts on TAC responsibilities toward Mass Decon limited in capabilities. Issue belongs to Local jurisdictions and training of 1<sup>st</sup> responders to accomplish Mass Decon as quickly as possible. Hazmat Tac will remain part of a larger group of Hospitals, health, fire and EMS professionals to help create guidance for local response capabilities.
