II. Summary: Regional Funding and Target Capabilities were the main discussion topics

<u>WMD/Hazardous Materials Target Capabilities Framework</u>: The committee "Brain Stormed" their questions and concerns over the Draft paper put out by DHS. The primary concerns were over response time standards. Another concern was clarification on working, i.e. what is meant by "rescue." There were several questions concerning the document that were not clear to TAC members.

The HM Chair is developing talking points (agenda), to include recommendations, and clarification on some points within the document. Once this is completed and distributed to the TAC members, Ohio EMA will work with the TAC Chair to set-up a conference call with DHS. Included in the conference call will be Regional Representive, the 3 C's, ONG 52nd, Mel House and OHS representative (Tracy Proud). All TAC members will be invited, but will be in a "mute" mode.

Regional Funding: Regional representatives were provided with the dollar figure that will be available to build-out the level 1 & 2 Teams. The amount allocated for Hazmat Capability build-out is \$424,000. Three items are necessary within a 60-day timeline beginning November 5, 2008: 1) Local EMA Point of Contact that will accept and administer the funding, 2) Amount of funding allocated to each region, and 3) Budget detail worksheets for equipment purchases.

The TAC Regional Coordinators identified who the grant administrators will be in each region. There was discussion concerning the distribution of the funding and the TAC was able to reach consensus and identify how much money will be distributed to perform their build-out of teams.
