#### 4. Old Business:

#### a. Site Visits

Region 1: Van Wert submitted a completed application and will host a site visit on August 9, 2013. Vedder requested TAC personnel to attend. Harry Burdick, Todd Truesdale, Jim Painter and the Ohio EMA Field Liaison volunteered to attend. Vedder will send a confirming email.

Per the regional coordinators the following teams will not be verifying and should be removed from the State Emergency Response Plan: Clermont County, Madison County and the City of Akron (they verified as part of the Summit County Type 1 Team).

- b. <u>Training</u> Phil Johnson reviewed HMEP direct training opportunities available for period of Oct 2013-Sept 2014. Also discussed concerns about proposed Wright State Tox Medic training. They will offer both a five day and a two day program. Hazmat IQ and CSU will continue to be funded. HMO/HMSO will also be eligible and funded.
- c. <u>ODH Survey and Hazmat Team Database Update</u>: Eric St. Germain provided an update on the ODH survey. He had updates from several other counties and will continue to work on the list.

#### d. Resource Capability Assessment Project (RCAP)

Jim Dwertman reported that the Master Asset List of Specialized Resources and capabilities was being completed by Tetratech. Vedder advised he had provided the hazmat team roster as directed. Tetratech will be verifying the info. Vedder reported that we will await the results from the RCAP to use as the basis for the Mass Decon Capability list.
